## WESTERN CANADIAN REGIONAL WALKING HORSE FUTURITY

\*\*\*All Futurity Entries must be shown in English Tack & Attire\*\*\*

### **Purpose**

The purpose of the Western Canadian Regional TWHBEA Futurity is to breed and promote quality stallions, mares and foals within the Western Canadian regional area.

### **General Provisions**

1. All horses will be exhibited and judged under the rules of S.H.O.W. HIO
2. Horses may not show out of age group.

### **Liability**

No entry is liable for more than the amount paid in, but there will be no return of payment. The right is reserved to reject any entry and to bar any entry from competition for failure to comply with the conditions of the Futurity.

### **Disputes and Protests**

All disputes, protests and rule clarifications shall be handled by the Show Committee. Their decisions shall be final.

### **Eligibility of Horses**

1. The Western Canadian Regional area is made up of the four western Canadian Provinces: Manitoba, Saskatchewan, Alberta and British Columbia.
2. All entries must have been bred and/or foaled by an owner/nominator living in the Western Canadian Region.
3. All horses shown must be offspring of stallions and mares who have been registered with the Tennessee Walking Horse Breeders' and Exhibitors' Association (TWHBEA).
4. All entries must furnish a photocopy of the TWHBEA Registration Papers for each entry.
5. Horses may be nominated at any time, but ALL previous years' back fees and penalties must be paid.

### **Nomination of Sire**

1. To nominate a stallion in the Futurity, it is necessary that (1) the stallion be registered in the TWHBEA Stud Book, and (2) a fee of \$50.00 be paid to the Futurity for the year in which the foal is eligible for the Weanling Division of the Futurity.
2. A nomination fee for a stallion need only be paid once in any year regardless of the number of weanlings nominated..
3. Where an entry is nominated for the first time in a year after the weanling year of the entry, there will be an additional fee for nomination of the Sire even if the Sire was nominated in the entry's weanling year.

### **Nomination of Dam**

1. To nominate a mare in the Futurity, it is necessary that (1) the mare be registered in the TWHBEA Stud Book, and (2) a fee of \$15.00 be paid to the Futurity for the year in which the foal is eligible for the Weanling Division of the Futurity.
2. Where an entry is nominated for the first time in a year after the weanling year of the entry, there will be an additional fee for nomination of the Mare.

### **The Weanling Division**

In order to make a foal eligible to show in the Weanling Division of the Futurity, the following conditions must be complied with:

1. The foal must have been bred by and/or foaled by an owner who lives in the Western Canadian Region.
2. The sire and dam must be nominated in the Futurity in the year in which the foal is born, or the appropriate penalties paid.
3. Where a registration certificate has not been received for the weanling, it is necessary to submit a copy of the sire's and the dam's registration papers with the nomination form for the weanling.
4. If a weanling's registration, name and number have not been received at the time of nomination, enter the first choice name and write pending for the number.
5. A fee of \$20.00 must be paid to the Futurity on or before the nomination deadline of the Weanling Year, or late fees paid.
6. Entries are to be shown in hand, and the S.H.O.W. HIO Tack and Attire Rules must be followed.

### **The Yearling Division**

In order to make a colt, filly or gelding eligible to be shown in the Yearling Division of the Futurity, the following conditions must be complied with:

1. The colt, filly or gelding must have been entered in the Weanling Division of this Futurity and all conditions and requirements of the Weanling Division must have been fulfilled, or late entry penalty fees paid.
2. *If the registration papers for the entry were not submitted in the weanling year, please be sure to include a copy of the TWHBEA Registration Certificate with your entry.*
3. A fee of \$30.00 must be paid to the Futurity on or before the deadline for nominations in the Yearling Year, or late fees paid.
4. Yearling entries are to be shown in hand and the S.H.O.W. HIO. Tack and Attire Rules must be followed.

### **Youth Weanling/Yearling Class**

1. There will be a separate class for youth handlers with weanling or yearling entries. Entries must be nominated in the weanling/yearling division, and all fees required paid. The fee to enter the youth class is \$20.00 per entry, in addition to the fees to nominate in the weanling/yearling division.
2. There will not be a futurity payout for the youth class, however, \$10.00 of every entry fee for this class will be repaid to the entries in this class as follows: 50% to 1<sup>st</sup> place, 35% to 2<sup>nd</sup> place, and 15% to 3<sup>rd</sup> place.
3. The top four entries will be eligible to show in the championship on Saturday evening.
4. This will not be a qualifying class for get of sire or produce of dam.

### **Weanling & Yearling Championship**

1. There will be a weanling and yearling championship class on Saturday evening. It will not be necessary to enter these classes. The top four entries in each of the weanling colts and fillies, and yearling colts and fillies will show back in the weanling and yearling championship, respectively.
2. The top four youth weanling/yearling entries will also be eligible to show in the weanling/yearling championship class.

### **The Two Year Old Division**

In order to make a colt, filly or gelding eligible to be shown in the Two Year Old Division of the Futurity, the following conditions must be complied with:

1. The colt, filly or gelding must have been entered in the Weanling and Yearling Divisions of the Futurity and all conditions and requirements of those divisions must have been fulfilled or late entry penalty fees paid.
2. A fee of \$30.00 must be paid to the Futurity on or before the deadline for nominations in the Two Year Old Year, or late fees paid.
3. Two Year Olds may be shown in hand or under saddle, ***but fees must be paid for each class entered***. Entries may be made in either or both of the Two Year Old In Hand or Under Saddle classes.
4. ***Points will be counted from only the highest placing class if entered in both under saddle & in hand.***
5. Entries may be shown in hand and the S.H.O.W. HIO Tack and Attire Rules must be followed.
6. Two Year Old Entries may also be shown under saddle. Entries must be shown in English Tack only, pursuant to the S.H.O.W. HIO Tack and Attire Rules.

### **The Three Year Old Division**

In order to make a colt, filly or gelding eligible to show in the Three Year Old Division of the Futurity, the following conditions must be complied with:

1. The colt, filly or gelding must have been entered in the Weanling, Yearling and Two Year Old Division of the Futurity and all conditions and requirements of these Divisions must have been fulfilled or late entry penalty fees must be paid.
2. A fee of \$30.00 is to be paid to the Futurity on or before the deadline for nominations in the Three Year Old Year, or late entry fees paid.
3. Entries are to be shown 2 gait, under saddle. Entries are to be shown under English Tack in accordance with the S.H.O.W. HIO Tack and Attire Rules.

### **Four and Five Year Old Division**

In order to make a colt, filly or gelding eligible to show in the Four and Five Year Old Division of the Futurity, the following conditions must be complied with:

1. The colt, filly or gelding must have been entered in the Weanling, Yearling, Two Year Old and Three Year Old Divisions of the Futurity and all conditions and requirements of these Divisions must have been fulfilled or late entry penalty fees must be paid.
2. A colt, filly or gelding may show in this Division in either its Four Year Old Year or its Five Year Old Year, but may not show in this Division in both years.
3. A fee of \$30.00 must be paid to the Futurity on or before the deadline for nominations in either its Four Year Old or Five Year Old Year, or late entry fees paid.
4. Entries are to be shown 3 gait, under saddle. Entries are to be shown under English Tack in accordance with the S.H.O.W. HIO Tack and Attire Rules.

### **Mare and Foal Division**

In order to make a Mare and Foal eligible to show in the Mare and Foal Division of the Futurity, the following conditions must be complied with:

1. The foal must have been bred by and/or foaled by an owner who lives in the Western Canadian Region.
2. The Sire and Dam must be nominated in the Futurity in the year in which the foal is born.
3. The foal must be registered with the TWHBEA or registration must have been submitted to the TWHBEA at the time of showing. Proof of registration or a copy of the application for registration for the foal must be presented before and entry number can be issued.
4. A fee of \$20.00 must be paid to the Futurity on or before the deadline for nominations in the Weanling Year, or late entry fees paid.
5. Entries are to be shown in hand. Both the mare and foal will be led into the ring, the mare in bridle, the foal in halter. S.H.O.W. HIO Tack and Attire Rules will apply. The entry will be judged on conformation and way of going. The dam counts 50% and the foal count 50%.

### **Get of Sire Division**

In order to be eligible to show Get of Sire in this Division, the following conditions must be complied with:

1. All entries to be shown in this Division must have been bred by and/or foaled by an owner who lives within the Western Canadian Region. The entries need not to have been bred by or foaled by the same owner.
2. The Sire and all Dams must be nominated in the Futurity in the years in which each entrant in the Division was eligible in the Weanling Division.
3. All entrants must be entered in the Futurity in their Weanling Year and every subsequent year in which they were eligible, and all the terms and conditions of those Divisions must have been fulfilled for each entrant for each year or late entry penalty fees paid for any entrant where the conditions and requirements of the applicable Divisions have not been met.
4. A fee of \$20.00 is to be paid to the Futurity on or before the deadline for nomination in the entry Year for this Division, or late entry fees paid.
5. Entries are to be shown in hand. Two entrants per sire are to be led into the ring and are to be judged on conformation and way of going. Get from any Division of the Futurity are eligible for this Division, except the Mare and Foal Division. Get must come from two separate Divisions.
6. The Sire may be represented in this class along with his get, but the presentation of the Sire is not mandatory.

### **Produce of Dam**

In order to be eligible to show Produce of Dam in this Division, the following conditions must be complied with:

1. All entries must have been bred by and/or foaled by an owner who lives in within the Western Canadian Region. The entries need not have been bred or foaled by the same owner.
2. The Sire and Dam must be nominated in the Futurity in the years in which each entrant in this Division was eligible for the Weanling Division.
3. All entrants must have been entered in the Futurity in their Weanling Year and every year subsequent in which they were eligible, and all conditions and requirements of those Divisions must have been fulfilled for each entrant for each year, or late entry penalty fees paid for any entrant for those Divisions where the conditions and requirements have not been met.
4. A fee of \$20.00 is to be paid to the Futurity on or before the deadline for nominations in the entry year for this Division, or late entry fees paid.
5. Entries are to be shown in hand. Two entrants per dam are to be led into the ring and are to be judged on conformation and way of going. Eligible entrants are produce from any Division of this Futurity, except the Mare and Foal Division. Entrants for each dam must come from two separate Divisions.
6. The Dam may be presented in this class along with her produce, but presentation of the Dam is not mandatory.

### **High Point Stallion and High Point Dam**

1. There will be an award presented to the Stallion and Mare whose offspring accumulated the highest number of points during the Futurity. Points will be awarded on the basis of 1<sup>st</sup> – 10 pts., 2<sup>nd</sup> – 9 pts., 3<sup>rd</sup> – 8 pts., 4<sup>th</sup> – 7 pts., 5<sup>th</sup> – 6 pts., 6<sup>th</sup> – 5pts., 7<sup>th</sup> – 4 pts., and 8<sup>th</sup> – 3 pts. The Youth classes, Get of Sire, Produce of Dam, and Mare and Foal classes are excluded.

### **Graduate Award**

An award will be presented to the horse ***that has paid entry fees*** for all five years, ***back paid horses do not qualify for the Graduate Award*** (Weanling to Four/Five Year Old) and accumulates the highest point score. Points will be tallied the same as for the High Point Stallion and Dam Awards.

### **Late Entry Fees**

1. Where entries are received after the deadline, a late fee of 50% of the total entry fee due that year will be assessed.
2. Where an entry was not entered in the weanling year, or was entered in the weanling year, but certain subsequent nomination years were not paid, an entry may be brought current by paying all outstanding entry fees for the entry plus a 50% penalty on outstanding entry fees. As well, the sire and the dam of the entry must have been nominated for the weanling year, or the nomination fees for the sire and dam paid. There is no penalty on the sire and dam nomination fees.
